Gadi Algazi is senior lecturer at the Department of History, Tel Aviv University, and editor of *History & Memory: Studies in the Representation of the Past.* His book on seigniorial power and violence in late medieval Germany was published in 1996 (*Herrengewalt und Gewalt der Herren im späten Mittelalter: Herrschaft, Gegenseitigkeit und Sprachgebrauch*, (Frankfurt am Main/New York: Campus, 1996) and the volume *Negotiating the Gift: Pre-Modern Figurations of Exchange*, edited together with Valentin Groebner and Bernhard Jussen is to be published in 2002. He is currently working on a research project on the shaping of the scholarly habitus, 1400-1700.

Carolyn Chapell Lougee is professor of history and chair of the History Department at Stanford University.
